## **PROMOTER/EXHIBITOR AGREEMENT**

1. Exhibitor agrees to maintain tables during the hours the show is open to the public and not to break down tables before the conclusion of the show without permission of the show promoter.
2. Each exhibitor is entitled to two (2) badges per table.
3. Exhibitor agrees to comply with all fire and safety laws, and with all local, state and federal laws, and not hold the promoter and/or Merchants Square Mall responsible for any breaches, losses, or damages to themselves or their property.
4. The Promoter and/or Merchants Square Mall will not be responsible for any injury to any Exhibitor or any loss or damage to any exhibitor's property from any cause whatsoever, while such property is in transit to or from or while at the Merchants Square Mall. Exhibitors desiring insurance coverage must obtain it on their own and at their own expense. Further, the exhibitor agrees to hold Non-Sport Update, their agents and employees, blameless in the event of injury or loss.
5. Unloading is at the ground level double-doors of the Merchant Square Mall Showroom (not at the front entrance). Signs will be posted to help direct you. This area is for merchandise in and out only, and must be cleared after use.
6. Exhibitor agrees to adhere to all the terms and conditions that have been agreed to between Non-Sport Update and Merchants Square Mall.
7. Obtaining a Pennsylvania State Sales Tax Permit and correctly collecting, reporting, and remitting such taxes are the responsibility of the exhibitor. List your Pennsylvania State Sales Tax ID# on the front, or indicate you are in the process of obtaining it.
8. Exhibitor understands that no refunds or credits will be issued if the exhibitor is unable to attend the show.
9. Exhibitors may not display any adult-oriented material. Exhibitor agrees to be bound by this and to immediately remove any material that the show promoter asks him/her to.
10. Exhibitor's completing the reverse side of his/her form, signing it, and remitting it with payment for table(s), or otherwise setting up at the show, constitutes acceptance of all of these terms and conditions.
